BONDS OFFERED FOR SALE AT COMPETITIVE BID: The Board of Directors (the "Board") of Fort Bend County Municipal Utility District No. 190 (the "District") is offering for sale at competitive bid \$2,130,000 Unlimited Tax Road Bonds, Series 2022A (the "Series 2022A Bonds").

<u>METHODS FOR SUBMISSION OF BIDS AND BID FORMS</u>: Bids for the Series 2022A Bonds may be submitted by any one the following methods:

- 1. Submit bids in writing as described below under "WRITTEN BIDDING PROCEDURE."
- 2. Submit bids electronically as described below under "ELECTRONIC BIDDING PROCEDURE."
- 3. Submit bids by telephone as described below under "TELEPHONIC BIDDING PROCEDURE."

All bids must be submitted by 9:30 A.M., Central Time, on Tuesday, August 9, 2022. Any prospective bidder must also submit, by 9:30 A.M., Central Time, on Tuesday, August 9, 2022, signed Official Bid Form(s) to the District's financial advisor, Robert W. Baird & Co. Incorporated (the "Financial Advisor"), as more fully described below. Any bid or bid form submitted after such scheduled time for bid receipt will not be accepted and will be returned unopened. The District will not accept bids by facsimile. See "CONDITIONS OF SALE – REQUIRED DISCLOSURE OF INTERESTED PARTIES" for additional requirements concerning submission of bids.

WRITTEN BIDDING PROCEDURE: A prospective bidder that intends to submit its bid in writing must do so in accordance with this paragraph. Two (2) sealed bids, which must be submitted on the Official Bid Form and plainly marked "Bid for Bonds," are to be addressed to "President and Board of Directors, Fort Bend County Municipal Utility District No. 190." ELECTRONIC BIDDING PROCEDURE: A prospective bidder that intends to submit an electronic bid must submit its electronic bid through the facilities of PARITY. A prospective bidder that intends to submit an electronic bid must also submit, prior to 9:30 A.M., Central Time, on Tuesday, August 9, 2022, one (1) signed copy of the Official Bid Form that is signed but otherwise incomplete to the Financial Advisor by e-mail to the following address: jbartholomew@rwbaird.com. Subscription to i-Deal's BIDCOMP Competitive Bidding System is required in order to submit an electronic bid. The District will neither confirm any subscription nor be responsible for the failure of any prospective bidder to subscribe. Electronic bids must be received via PARITY in the manner described below, until 9:30 A.M., Central Time, on Tuesday, August 9, 2022.

Electronic bids must be submitted via PARITY in accordance with this Official Notice of Sale, until 9:30 A.M., Central Time, but no bid will be received after the time for receiving bids specified above. An electronic bid made through the facilities of PARITY shall be deemed an irrevocable offer to purchase the Series 2022A Bonds on the terms provided in this Official Notice of Sale and shall be binding upon the bidder as if made by a signed, sealed bid delivered to the District. The District shall not be responsible for any malfunction or mistake made by, or as a result of the use of the facilities of, PARITY, the use of such facilities being the sole risk of the prospective bidder.

If any provisions of this Official Notice of Sale shall conflict with information provided by PARITY as the approved provider of electronic bidding services, this Official Notice of Sale shall control. Further information about PARITY, including any fee charged, may be obtained from i-Deal, 1359 Broadway, 2nd Floor, New York, New York 10018, (212) 849-5000.

For purposes of the electronic bidding process, the time as maintained by PARITY shall constitute the official time. AWARD AND SALE OF THE SERIES 2022A BONDS: The District will take action to adopt a resolution authorizing the issuance and awarding sale of the Series 2022A Bonds (the "Series 2022A Bond Resolution") or will reject any and all bids promptly after the opening of bids at 11:00 A.M., Central Time, on Tuesday, August 9, 2022, at the District's regular meeting place at the office of Allen Boone Humphries Robinson LLP, 3200 Southwest Freeway, Suite 2600, Houston, Texas, 77027. The Board reserves the right to reject any or all bids and to waive any irregularities, except time of filing. Please note that all bids must comply with the requirement listed in "CONDITIONS OF SALE – REQUIRED DISCLOSURE OF INTERESTED PARTIES."

THE SERIES 2022A BONDS

DESCRIPTION OF CERTAIN TERMS OF THE SERIES 2022A BONDS: The Series 2022A Bonds will be dated September 1, 2022, and accrue interest from September 8, 2022, with interest payable on March 1, 2023, and on each September 1 and March 1 thereafter (each an "Interest Payment Date") until the earlier of maturity or prior redemption. The Series 2022A Bonds will be issued only in fully registered form. Principal is payable to the registered owner(s) of the Series 2022A Bonds (the "Bondholder(s)") upon presentation and surrender at the principal corporate trust office of the paying agent/registrar, initially, Regions Bank, an Alabama banking corporation, Houston, Texas, (the "Paying Agent/Registrar"). Interest on the Series 2022A Bonds will be payable by check of the Paying Agent/Registrar, dated as of the Interest Payment Date, and mailed by the Paying Agent/Registrar to the Bondholders, as shown on the records of the Paying Agent/Registrar at the close of business on the 15th day of the calendar month next preceding each Interest Payment Date (the "Record Date"). The Series 2022A Bonds will be registered in the name of Cede & Co. as nominee for The Depository Trust Company, New York, New York ("DTC"), which will act as securities depository for the Series 2022A Bonds. Beneficial owners of the Series 2022A Bonds will not receive physical certificates representing the Series 2022A Bonds, but will receive a credit balance on the books of the nominees of such beneficial owners. So long as Cede & Co. is the registered owner of the Series 2022A Bonds, the principal of and interest on the Series 2022A Bonds will be paid by the Paying Agent/Registrar directly to DTC, which will, in turn, remit such principal and interest to its participants for subsequent disbursement to the beneficial owners of the Series 2022A Bonds as described herein. See "THE BONDS - Book-Entry-Only System" in the Preliminary Official Statement.

<u>SERIAL BONDS AND TERM BONDS</u>: Bidders may provide that all the Series 2022A Bonds be issued as serial bonds or may provide that any two or more consecutive annual principal amounts may be combined into one or more term bonds.

REDEMPTION PROVISIONS: The Series 2022A Bonds maturing on and after September 1, 2030, are subject to redemption and payment, at the option of the District, in whole or, from time to time, in part, on September 1, 2029, or on any date thereafter, at a price equal to the principal amount thereof, plus accrued interest thereon to the date fixed for redemption. If less than all the Series 2022A Bonds are redeemed at any time, the District shall determine the maturity or maturities and the amounts thereof to be redeemed, in integral multiples of \$5,000 in principal amount, and if less than all of the Series 2022A Bonds within a maturity are to be redeemed, the Paying Agent/Registrar shall select by lot or other customary method of random selection the Series 2022A Bonds within such maturity to be redeemed. The holder of any Series 2022 Bond, all or a portion of which has been called for redemption, will be required to present such Series 2022 Bond to the Paying Agent/Registrar for payment of the redemption price on the portion of such 2022A Bonds called for redemption and for the issuance of an exchange 2022A Bonds in a principal amount equal to the portion of the Series 2022 Bond not so redeemed.

<u>SECURITY FOR PAYMENT</u>: Principal of and interest on the Series 2022A Bonds are payable from the proceeds of a continuing, direct annual ad valorem tax, without legal limitation as to rate or amount, levied against taxable property located within the District. The Series 2022A Bonds are obligations solely of the District and are not obligations of the State of Texas; Fort Bend County, Texas; the City of Iowa Colony, Texas; or any entity other than the District.

<u>OTHER TERMS AND COVENANTS</u>: Other terms of the Series 2022A Bonds and the various covenants of the District contained in the Series 2022A Bond Resolution are described in the Preliminary Official Statement, to which reference is made for all purposes.

MUNICIPAL BOND INSURANCE AND RATING: The District has made an application to Build America Mutual Assurance Company and Assured Guaranty Municipal Corporation for a commitment for municipal bond guaranty insurance on the Series 2022A Bonds. THE PAYMENT OF ALL COSTS ASSOCIATED WITH THE INSURANCE, IF AVAILABLE, INCLUDING THE PREMIUM CHARGED BY THE INSURANCE COMPANY AND FEES CHARGED BY RATING COMPANIES, OTHER THAN MOODY'S, WILL BE AT THE OPTION AND EXPENSE OF THE SERIES 2022A BONDS INITIAL PURCHASER (HEREIN DEFINED). THE DISTRICT WILL PAY THE RATING FEES CHARGED BY MOODY'S. Moody's has assigned an underlying credit rating of "Baa2" with stable outlook to the Series 2022A Bonds. See "MUNICIPAL BOND INSURANCE" and "MUNICIPAL BOND RATING" in the Preliminary Official Statement.

CONDITIONS OF SALE

TYPES OF BIDS AND INTEREST RATES: The Bonds will be sold in one block on an "all or none" basis at a price of not less than 97% of the par value thereof, plus accrued interest from the date of the Bonds to the date of delivery. Bidders are to name the rates of interest to be borne by the Bonds, provided that each interest rate bid must be a multiple of 1/8th or 1/20th of 1%. All Bonds maturing within a single year must bear the same rate of interest. The net effective interest rate on the Bonds may not exceed 5.54%, as calculated pursuant to Chapter 1204 of the Texas Government Code. No limitation will be imposed upon bidders as to the number of rates which may be used, but the highest rate bid may not exceed the lowest rate bid by more than 2-1/2% in interest rate. No bids involving supplemental interest payments will be considered. No bid that generates a cash premium greater than \$5,000 will be considered. Each bid shall indicate the total and net interest costs in dollars and the net effective interest rate determined therefrom, which shall be considered informative only and not as a part of the bid.

BASIS OF AWARD: For the purpose of awarding sale of the Series 2022A Bonds, the interest cost of each bid will be computed by determining, at the rates specified therein, the total dollar value of all interest on the Series 2022A Bonds from the date thereof to their respective maturities and adding thereto the discount bid, if any. Subject to the District's right to reject any or all bids, sale of the Series 2022A Bonds will be awarded to the bidder (the "Series 2022A Bonds Underwriter") whose bid, under the above computation, produces the lowest net interest cost to the District. The Board reserves the right to reject any or all bids. In the event of mathematical discrepancies between the interest rate(s) bid and the interest cost determined therefrom, as both appear on the Official Bid Form, the bid will be governed solely by the interest rate(s) bid.

GOOD FAITH DEPOSIT: Each bid must be accompanied by a bank cashier's check payable to the order of "Fort Bend County Municipal Utility District No. 190" in the amount of \$42,600 which is 2% of the par value of the Series 2022A Bonds (the "Good Faith Deposit"). "Official Checks" will not be accepted. The check of the Series 2022A Bonds Underwriter will be considered as the Good Faith Deposit and will be retained uncashed by the District pending the Series 2022A Bonds Underwriter's compliance with the terms of the bid. In the event the Series 2022A Bonds Underwriter should fail or refuse to take up and pay for the Series 2022A Bonds in accordance with such terms, then the Good Faith Deposit will be cashed and the proceeds accepted by the District as full and complete liquidated damages. The Good Faith Deposit may accompany the bid or it may be submitted separately; if submitted separately, it shall be made available to the District prior to the opening of the bids and shall be accompanied by instructions from the bank on which it is drawn which authorize its use as the Good Faith Deposit of bidders named in such instructions. THE GOOD FAITH DEPOSIT OF THE SERIES 2022A BONDS UNDERWRITER WILL BE RETURNED TO THE SERIES 2022A BONDS UNDERWRITER UNCASHED ON THE DATE OF DELIVERY OF THE SERIES 2022A BONDS. No interest will be credited on the Good Faith Deposit. The checks accompanying all other bids will be returned immediately after the bids are opened and the award of the sale of the Series 2022A Bonds has been made.

COMPETITIVE BIDDING AND CERTIFICATE OF SERIES 2022A BONDS UNDERWRITER: In the event that the District does not receive sufficient qualified bids for both the Series 2022 Bonds and the Series 2022A Bonds to satisfy the competitive sale requirements of Treasury Regulation § 1.148-1(f)(3)(i), allowing the District to treat the reasonably expected initial offering price to the public as of the sale date as the issue price of the Series 2022 Bonds and the Series 2022A Bonds, the "hold-the-offering-price rule" shall apply, which will allow the District to treat the initial offering price to the public of each maturity as of the sale date as the issue price of that maturity (the "hold-the-offering- price rule"). So long as the hold-theoffering-price rule applies to any maturity of the Series 2022 Bonds or the Series 2022A Bonds, the Series 2022A Bonds Underwriter will neither offer nor sell that maturity to any person at a price that is higher than the initial offering price to the public during the period starting on the sale date and ending on the earlier of the following: (i) the date on which the Series 2022A Bonds Underwriter has sold at least 10 percent of that maturity of the Series 2022A Bonds to the public at a price that is no higher than the initial offering price to the public or (b) the close of the fifth business day after the sale date. The Series 2022A Bonds Underwriter agrees to promptly report to the District's financial advisor when it has sold 10 percent of a maturity of the Series 2022A Bonds to the public at a price that is no higher than the initial offering price to the public if that occurs prior to the close of the fifth business day after the sale date. Alternative Certificates of Series 2022A Bonds Underwriter are attached for use (I) when the competitive sale requirements of Treasury Regulation § 1.148-1(f)(3)(i) are met and (II) when such requirements are not met.

REQUIRED DISCLOSURE OF INTERESTED PARTIES: Bidders, including any syndicate member listed on the Official Bid Form, who are not publicly traded business entities, or wholly owned subsidiaries of a publicly traded business entity, must submit to the District a completed and signed Texas Ethics Commission Form 1295 ("TEC Form 1295") in accordance with Texas Government Code Section § 2252.908. If required, the TEC Form 1295 may accompany the Official Bid Form or may be submitted separately, but must be provided to the District prior to the time prescribed for the award of the Series 2022A Bonds. If required the TEC Form 1295 may be provided to the District via facsimile or electronically; however, the original signed TEC Form 1295, including certificate number, must be physically delivered to the District within two business days of the award. The District reserves the right to reject any bid that does not comply with the requirements prescribed herein, if applicable, or to waive any such requirements. For purposes of completing the TEC Form 1295, box two is "Fort Bend County Municipal Utility District No. 190" and box 3 is "FBMUD 190 – S2022A – B." Neither the District nor its consultants have the ability to verify the information included in a TEC Form 1295, and neither have an obligation nor undertake responsibility for advising any bidder with respect to the proper completion of the TEC Form 1295. Consequently, any entity who is not a publicly traded business entity, or a wholly owned subsidiary of a publicly traded business entity, should consult its own advisors to the extent it deems necessary and be prepared to submit the completed form promptly upon notification from the District that its bid is the apparent winning bid.

COMPLIANCE WITH LAWS PROHIBITING CONTRACTS WITH CERTAIN COMPANIES: The District will not award the Series 2022A Bonds to a bidder unless the bidder verifies on behalf of itself and each syndicate member listed on the Official Bid Form that, to the extent the Official Bid Form represents a contract for goods or services within the meaning of Section 2271.002 of the Texas Government Code, as amended, solely for purposes of Chapter 2271 of the Texas Government Code, and except to the extent otherwise required by applicable federal law, at the time of execution and delivery of its bid and through the delivery date of the Series 2022A Bonds, neither the bidder nor a syndicate member listed on the Official Bid

Form is a Company¹ that boycotts or will boycott Israel. The terms "boycotts Israel" and "boycott Israel" as used in this paragraph have the meaning assigned to the term "boycott Israel" in Section 808.001 of the Texas Government Code, as amended.

Additionally, the District will not award the Series 2022A Bonds to a bidder unless the bidder certifies that, to the extent the Official Bid Form represents a governmental contract within the meaning of Section 2252.151 of the Texas Government Code, as amended, solely for purposes of Chapter 2252 of the Texas Government Code, and except to the extent otherwise required by applicable federal law, at the time of execution and delivery of its bid, neither the bidder nor a syndicate member listed on the Official Bid Form is a Company² (i) that engages in business with Iran, Sudan, or any foreign terrorist organization as described in Chapter 2270 of the Texas Government Code, or Subchapter F of Chapter 2252 of the Texas Government Code, or (ii) listed by the Texas Comptroller of Public Accounts under Section 2270.0201 or 2252.153 of the Texas Government Code. The term "foreign terrorist organization" as used in this paragraph has the meaning assigned to such term in Section 2252.151 of the Texas Government Code.

Additionally, the District will not award the Series 2022A Bonds to a bidder unless the bidder verifies on behalf of itself and each syndicate member listed on the Official Bid Form that, to the extent the Official Bid Form represents a contract for goods or services within the meaning of Section 2274.002 of the Texas Government Code (as added by Senate Bill 13, 87th Texas Legislature, Regular Session), as amended, solely for purposes of Chapter 2274 of the Texas Government Code, and except to the extent otherwise required by applicable Texas or federal law, at the time of execution and delivery of its bid and through the delivery date of the Series 2022A Bonds, neither the bidder nor a syndicate member listed on the Official Bid Form is a Company¹ that boycotts or will boycott energy companies. The terms "boycotts energy companies" and "boycott energy companies" shall have the meaning assigned to the term "boycott energy company" in Section 809.001 of the Texas Government Code, as amended.

Additionally, the District will not award the Series 2022A Bonds to a bidder unless the bidder verifies on behalf of itself and each syndicate member listed on the Official Bid Form that, to the extent the Official Bid Form represents a contract for the purchase of goods or services within the meaning of Section 2274.002 of the Texas Government Code (as added by Senate Bill 19, 87th Texas Legislature, Regular Session, "SB 19"), as amended, solely for purposes of Chapter 2274 of the Texas Government Code, and except to the extent otherwise required by applicable Texas or federal law, at the time of execution and delivery of its bid and through the delivery date of the Bonds, neither the bidder nor a syndicate member listed on the Official Bid Form is a Company² that has a practice, policy, guidance or directive that discriminates against a firearm entity or firearm trade association. The term "discriminates against a firearm entity or firearm trade association" as used in this paragraph has the meaning assigned to the term "discriminate against a firearm entity or firearm trade association" in Section 2274.001(3) of the Texas Government Code (as added by SB 19).

CONTRACTING INFORMATION: As a condition of sale, the Series 2022A Bonds Underwriter represents and warrant that, to the extent the purchase of the Series 2022A Bonds represents a contract for goods or services within the meaning of Section 552.371 of the Texas Government Code, as amended, the Series 2022A Bonds Underwriter represents and warrant that it will (i) preserve all contracting information related to the purchase of the Series 2022A Bonds as provided by the records retention requirements applicable to the District through the delivery date of the Series 2022A Bonds, (ii) promptly provide to the District any contracting information related to the purchase of the Series 2022A Bonds that is in the custody or possession of the Series 2022A Bonds Underwriter on request of the Issuer, and (iii) upon delivery of the Series 2022A Bonds, either (a) provide at no cost to the District all contracting information related to the purchase of the Series 2022A Bonds that is in the custody or possession of the Series 2022A Bonds Underwriter or (b) preserve the contracting information related to the purchase of the Series 2022A Bonds as provided by the records retention requirements applicable to the District. The term "contracting information" as used in this paragraph has the meaning assigned to such term in Section 552.003 of the Texas Government Code.

¹ "Company" means a for-profit organization, association, corporation, partnership, joint venture, limited partnership, limited liability partnership, or limited liability company, including a wholly owned subsidiary, majority-owned subsidiary, parent company, or affiliate of those entities or business associations that exists to make a profit, but does not mean a sole proprietorship.

² "Company" means a sole proprietorship, organization, association, corporation, partnership, joint venture, limited partnership, limited liability partnership, limited liability company, or other entity or business association whose securities are publicly traded, including a whollyowned subsidiary, majority-owned subsidiary, parent company, or affiliate of those entities or business associations, that exists to make a profit.

OFFICIAL STATEMENT

To assist the Series 2022A Bonds Underwriter in complying with Rule 15c2-12 (the "Rule") of the United States Securities and Exchange Commission ("SEC"), the District and the Series 2022A Bonds Underwriter contract and agree, by the submission and acceptance of the winning bid, as follows:

FINAL OFFICIAL STATEMENT: The District has approved and authorized distribution of the accompanying Preliminary Official Statement for dissemination to potential purchasers of the Series 2022A Bonds but does not presently intend to prepare any other document or version thereof for such purpose, except as described below. Accordingly, the District intends the Preliminary Official Statement to be final as of its date, within the meaning of SEC Rule 15c2-12(b)(1), except for information relating to the offering prices, interest rates, final debt service schedule, selling compensation, identity of the Series 2022A Bonds Underwriter and other similar information, terms and provisions to be specified in the competitive bidding process. The Series 2022A Bonds Underwriter shall be responsible for promptly informing the District of the initial offering yields of the Series 2022A Bonds. Thereafter, the District will complete and authorize distribution of the Official Statement identifying the Series 2022A Bonds Underwriter and containing such omitted information. The District does not intend to amend or supplement the Official Statement otherwise, except to take into account certain subsequent events, if any, as described below. By delivering the final Official Statement or any amendment or supplement thereto in the requested quantity to the Series 2022A Bonds Underwriter on or after the sale date, the District intends the same to be final as of such date, within the meaning of the Rule. Notwithstanding the foregoing, the only representations concerning the absence of material misstatements or omissions from the Official Statement which are being or which will be made by the District are those described and contained in the Official Statement under the caption "OFFICIAL STATEMENT – Updating the Official Statement."

CHANGES TO OFFICIAL STATEMENT: If, subsequent to the date of the Official Statement, the District learns, through the ordinary course of business and without undertaking any investigation or examination for such purposes, or is notified by the Series 2022A Bonds Underwriter of any adverse event which causes the Official Statement to be materially misleading, and unless the Series 2022A Bonds Underwriter elects to terminate its obligation to purchase the Series 2022A Bonds, as described below under "DELIVERY AND ACCOMPANYING DOCUMENTS – CONDITIONS TO DELIVERY," the District will promptly prepare and supply to the Series 2022A Bonds Underwriter an appropriate amendment or supplement to the Official Statement satisfactory to the Series 2022A Bonds Underwriter; provided, however, that the obligation of the District to do so will terminate when the District delivers the Series 2022A Bonds to the Series 2022A Bonds Underwriter, unless the Series 2022A Bonds Underwriter notifies the District on or before such date that less than all of the Series 2022A Bonds have been sold to ultimate customers, in which case the District's obligations hereunder will extend for an additional period of time (but not more than 90 days after the date the District delivers the Series 2022A Bonds) until all of the Series 2022A Bonds have been sold to ultimate customers.

<u>DELIVERY OF OFFICIAL STATEMENTS</u>: The District shall furnish to the Series 2022A Bonds Underwriter (and to each participating underwriter of the Series 2022A Bonds, within the meaning of the Rule, designated by the Series 2022A Bonds Underwriter), within seven (7) business days after the sale date, the aggregate number of Official Statements specified in the winning bid. The District also shall furnish to the Series 2022A Bonds Underwriter a like number of any supplements or amendments approved and authorized for distribution by the District for dissemination to potential purchasers of the Series 2022A Bonds, as well as such additional copies of the Official Statement or any such supplements or amendments as the Series 2022A Bonds Underwriter may request prior to the 90th day after the end of the underwriting period described in SEC Rule 15c2-12(e)(2). The District shall pay the expense of preparing the number of copies of the Official Statement specified in the winning bid and an equal number of any supplements or amendments issued on or before the delivery date, but the Series 2022A Bonds Underwriter shall pay for all other copies of the Official Statement or any supplement or amendment thereto.

DELIVERY AND ACCOMPANYING DOCUMENTS

<u>DELIVERY OF INITIAL BONDS</u>: Initial delivery of the Series 2022A Bonds ("Initial Delivery") will be as set forth below. Unless otherwise agreed with the Series 2022A Bonds Underwriter, delivery will be at the corporate trust office of the Paying Agent/Registrar in Houston, Texas. Payment for the Series 2022A Bonds must be made in immediately available funds for unconditional credit to the District, or as otherwise directed by the District. If, at the time of closing, the Series 2022A Bonds Underwriter has provided the Paying Agent/Registrar five (5) business days' written notice of its registration instructions, the Series 2022A Bonds Underwriter shall not be required to pay for the initial Series 2022A Bonds until the Paying Agent/Registrar is able to deliver to the Series 2022A Bonds Underwriter definitive, registered Series 2022A Bonds conforming to such registration instructions. If for any reason the District is unable to make delivery

on or before October 7, 2022, then the District immediately shall contact the Series 2022A Bonds Underwriter and offer to allow the Series 2022A Bonds Underwriter to extend its offer for an additional thirty (30) days. If the Series 2022A Bonds Underwriter does not elect to extend its offer within six (6) days thereafter, then the Good Faith Deposit will be returned, and both the District and the Series 2022A Bonds Underwriter shall be relieved of any further obligation.

EXCHANGE ON DELIVERY DATE: Upon written request of the Series 2022A Bonds Underwriter, delivered to the Paying Agent/Registrar not less than five (5) business days prior to the date fixed for delivery, the Paying Agent/Registrar will, on the delivery date, exchange the Series 2022A Bonds to be delivered by the District for Series 2022A Bonds registered in accordance with instructions contained in such request, in integral multiples of \$5,000, maturing as set out in this Official Notice of Sale and bearing interest in accordance with the terms of the Series 2022A Bonds Underwriter's bid.

<u>CUSIP NUMBERS</u>: It is anticipated that CUSIP identification numbers will be printed on the Series 2022A Bonds, but neither the failure to print such number on any Bond nor any error with respect thereto shall constitute cause for a failure or refusal by the Series 2022A Bonds Underwriter to accept delivery of and pay for the Series 2022A Bonds in accordance with the terms of this Official Notice of Sale. All expenses relating to the printing of CUSIP numbers on the Series 2022A Bonds shall be paid for by the District; however, payment of the CUSIP Global Services charge for the assignment of the numbers shall be the responsibility of the Series 2022A Bonds Underwriter.

CONDITIONS TO DELIVERY: The obligation to take up and pay for the Series 2022A Bonds is subject to the following conditions: the issuance of an approving opinion of the Attorney General of Texas, the Series 2022A Bonds Underwriter's receipt of the initial Series 2022A Bonds (or definitive Series 2022A Bonds if the Series 2022A Bonds Underwriter has provided the Paying Agent/Registrar with registration instructions as provided above), the Series 2022A Bonds Underwriter's receipt of the legal opinion of Allen Boone Humphries Robinson LLP, Houston, Texas, Bond Counsel, and the no-litigation certificate, and the non-occurrence of the events described below under "NO MATERIAL ADVERSE CHANGE," all as described below. Further, the Series 2022A Bonds Underwriter is not obligated to take up and pay for the Series 2022A Bonds at Initial Delivery if at any time after the award of the Series 2022A Bonds and at or prior to Initial Delivery, the Congress of the United States shall have declared war or a national emergency. In addition, if the District fails to comply with its obligations described under "OFFICIAL STATEMENT" above, the Series 2022A Bonds Underwriter may terminate its contract to purchase the Series 2022A Bonds by delivering written notice to the District within five (5) days thereafter.

SERIES 2022A BONDS UNDERWRITER'S CERTIFICATION OF ISSUE PRICE: In order to provide the District with information required to enable it to comply with certain conditions of the Internal Revenue Code of 1986, as amended (the "Code"), relating to the exclusion of interest on the Series 2022A Bonds from gross income for federal income tax purposes, and subject to the section entitled "CONDITIONS OF SALE – COMPETITIVE BIDDING AND CERTIFICATE OF SERIES 2022A BONDS UNDERWRITER" herein, the Series 2022A Bonds Underwriter will be required to complete, execute and deliver to the District (on or before the date of delivery of the Series 2022A Bonds) a certification regarding the "issue price" of the Series 2022A Bonds in one of the forms accompanying this Official Notice of Sale. Each bidder, by submitting its bid, agrees to complete, execute, and deliver such a certificate by the date of delivery of the Series 2022A Bonds, if its bid is accepted by the District. It will be the responsibility of the Series 2022A Bonds Underwriter to institute such syndicate reporting requirements, to make such investigation, or otherwise to ascertain the facts necessary to enable it to make such certification with reasonable certainty. Any questions concerning such certification should be directed to Bond Counsel.

LEGAL OPINIONS: The District will furnish to the Series 2022A Bonds Underwriter a transcript of certain certified proceedings incident to the issuance and authorization of the Series 2022A Bonds, including a certified copy of the approving legal opinion of the Attorney General of Texas, as recorded in the Bond Register of the Comptroller of Public Accounts of the State of Texas, to the effect that the Attorney General of Texas has examined a transcript of proceedings authorizing the issuance of the Series 2022A Bonds, and that based upon such examination, the Series 2022A Bonds are valid and binding obligations of the District payable from the proceeds of an annual ad valorem tax, levied without legal limitation as to rate or amount upon all taxable property in the District. The District will also furnish the approving legal opinion of Bond Counsel, to the effect that, based upon an examination of such transcript, the Series 2022A Bonds are valid and binding obligations of the District under the Constitution and laws of the State of Texas, except to the extent that enforcement of the rights and remedies of the registered owners of the Series 2022A Bonds may be limited by laws relating to bankruptcy, reorganization, or other similar laws of general application affecting the rights of creditors of political subdivisions such as the District. The legal opinion of Bond Counsel will further state that the Series 2022A Bonds are payable, both as to principal and interest, from the levy of ad valorem taxes without legal limitation as to rate or amount, upon all taxable property within the District, and that, under existing law, interest on the Series 2022A Bonds is excludable from gross income for federal income tax purposes and interest on the Series 2022A Bonds is not subject to the alternative minimum tax on individuals. Such opinions express no opinion with respect to the sufficiency of the security for or marketability of the Series 2022A Bonds.

<u>DTC DEFINITIVE BONDS</u>: After delivery, the Series 2022A Bonds will be issued in book-entry-only form. Cede & Co. is the nominee for DTC. All references herein to the registered owners of the Series 2022A Bonds shall mean Cede & Co. and not the beneficial owners of the Series 2022A Bonds. Purchase of beneficial interests in the Series 2022A Bonds will be made in book-entry-only form (without registered Series 2022A Bonds) in the denomination of \$5,000 principal amount or any

integral multiple thereof. Under certain limited circumstances described herein, the District may determine to forego immobilization of the Series 2022A Bonds at DTC, or another securities depository, in which case, such beneficial interests would become exchangeable for one or more fully registered Series 2022A Bonds of like principal amount for the Series 2022A Bonds. See "THE BONDS – Book-Entry-Only System" in the Preliminary Official Statement.

NOT QUALIFIED TAX-EXEMPT OBLIGATIONS: The Series 2022A Bonds are not "qualified tax-exempt obligations" within the meaning of Section 265(b) of the Internal Revenue Code of 1986, as amended.

NO-LITIGATION CERTIFICATE: With the delivery of the Series 2022A Bonds, the President and Secretary of the Board will, on behalf of the District, execute and furnish to the Series 2022A Bonds Underwriter a certificate to the effect that no litigation of any nature has been filed or is then pending against the District, of which the District has notice, to restrain the issuance or delivery of the Series 2022A Bonds, or which would affect the provisions made for their payment or security, or in any manner questioning the validity of the Series 2022A Bonds.

NO MATERIAL ADVERSE CHANGE: The obligations of the Series 2022A Bonds Underwriter to take up and pay for the Series 2022A Bonds, and of the District to deliver the Series 2022A Bonds, are subject to the condition that, up to the time of delivery of and receipt of payment for the Series 2022A Bonds, there shall have been no material adverse change in the condition of the District (financial or otherwise) subsequent to the date of sale from that set forth in the Preliminary Official Statement, as it may have been finalized, supplemented or amended through the date of delivery.

GENERAL CONSIDERATIONS

<u>REGISTRATION</u>: The Series 2022A Bonds are transferable on the bond register kept by the Paying Agent/Registrar upon surrender and reissuance. The Series 2022A Bonds are exchangeable for an equal principal amount of Series 2022A Bonds of the same maturity in any authorized denomination upon surrender of the Series 2022A Bonds to be exchanged, but the District may require payment of a sum sufficient to cover any tax or governmental charge payable in connection therewith.

<u>INVESTMENT CONSIDERATIONS</u>: The Series 2022A Bonds are subject to investment risks as set forth in this Preliminary Official Statement. Prospective purchasers should review the entire Preliminary Official Statement before making an investment decision. See "INVESTMENT CONSIDERATIONS" in the Preliminary Official Statement.

<u>RESERVATION OF RIGHTS</u>: The District reserves the right to reject all bids or any bid not conforming with the terms hereof and the right to waive any and all irregularities, except time of filing.

NOT AN OFFER TO SELL: This Official Notice of Sale does not alone constitute an offer to sell the Series 2022A Bonds but is merely notice of sale of the Series 2022A Bonds. The invitation for bids on the Series 2022A Bonds is being made by means of this Official Notice of Sale, the Preliminary Official Statement, and the Official Bid Form.

SECURITIES REGISTRATION AND QUALIFICATION: No registration statement relating to the Series 2022A Bonds has been filed with the SEC under the Securities Act of 1933, as amended, in reliance upon exemptions provided thereunder. The Series 2022A Bonds have not been registered or qualified under the Securities Act of Texas in reliance upon various exemptions contained therein; nor have the Series 2022A Bonds been registered or qualified under the securities laws or regulations of any other jurisdiction. The District assumes no responsibility for registration or qualification of the Series 2022A Bonds under the securities laws or regulations of any other jurisdiction in which the Series 2022A Bonds may be offered, sold, or otherwise transferred. This disclaimer of responsibility for registration or qualification for sale or other disposition of the Series 2022A Bonds shall not be construed as an interpretation of any kind with regard to the availability of any exemption from securities registration or qualification provisions in such other jurisdictions.

By submission of a bid, the Series 2022A Bonds Underwriter represents that the sale of the Series 2022A Bonds in states other than Texas will be made only pursuant to exemptions from registration or qualification or, where necessary, the Series 2022A Bonds Underwriter will register or qualify the Series 2022A Bonds in accordance with the securities laws or regulations of any jurisdiction which so requires. The District agrees to cooperate, at the Series 2022A Bonds Underwriter's written request and expense, in registering or qualifying the Series 2022A Bonds, or in obtaining an exemption from registration or qualification, in any jurisdiction where such action is necessary.

The Series 2022A Bonds Underwriter's obligation to accept and pay for the Series 2022A Bonds is conditioned upon delivery to the Series 2022A Bonds Underwriter or its agent of a certified copy of the Series 2022 Bond Resolution containing the agreement described under such heading.
